- 3) The property is being auctioned with all the existing and future encumbrances whether known or unknown to IHFL. The intending bidder should make their own independent inquiries regarding the encumbrances, title of properties, discrepancy as to measurement, shortfall of area etc. put on auction and claims/rights/dues/affecting the property or any prior to submitting their bid. The E- auction advertisement does not constitute and will not be deemed to constitute any commitment or any representation by IHFL. - 4) The bids submitted without EMD amount and without proper KYC documents shall be summarily rejected.
