- 2) The auction of Immovable secured asset is on "as is where is" basis and "as is what is" basis and "whatever there is" basis and "no recourse" basis for and on behalf of the Secured Creditor viz. IHFL as mentioned in auction notice.
- 3) The property is being auctioned with all the existing and future encumbrances whether known or unknown to IHFL. The intending bidder should make their own independent inquiries regarding the encumbrances, title of properties, discrepancy as to measurement, shortfall of area etc. put on auction and claims/rights/dues/affecting the property or any prior to submitting their bid.
